	<b><u>Full Payment of Minimum Sustaining Contribution - Check or Credit Card by August 31 – (no credit card charge pass along)</u></b>
	<b><u>Traditional Payment Plan</u></b> - All financial commitments to be paid as follows: 33% by September 1 <sup>st</sup> and 2/3 by December 31 <sup>st</sup> . Remainder by March 31. Payments may be made by check or credit card (credit card payments will include a 2% pass along of the credit card company charges).
	<b><u>9 Payment Plan (Credit Card)</u></b> - All financial commitments to be charged in 9 equal monthly installments from July through March (on or around the 10 <sup>th</sup> of each month) of the current fiscal year. A \$10 processing fee will be added to each payment. Valid credit card information must be provided in advance (see below).
	<b><u>9 Payment Plan (Post Dated Check)</u></b>
	<b><u>Special Arrangements</u></b> – I request a meeting with the members of the Finance Committee to discuss special arrangements as my financial circumstances do not permit me to make payments through either of the above options. I will provide documentation as requested by the Finance Committee to support my request.

*Any congregant with past due balances should settle these charges prior to August 31<sup>st</sup>. All payments received will automatically be applied to past balances and congregants will need to follow the selected option for current year obligations to receive High Holy Day tickets. Late fees will be assessed for overdue payments beyond March 31 at .5% per month.*

Failure to meet mutually agreed upon payment arrangements, may cause the synagogue to deny or suspend Bar/Bat Mitzvah preparation, cancellation of Bar/Bat Mitzvah dates, barring of attendance of children in religious or pre-school. In reliance on your agreement to these payment obligations, you will have the right s for High Holiday Tickets.
